## CMAL County Government Study Committee – Mindy Greiling, Study Chair

CMAL members will be hard at work this summer and fall on a robust study of metro area county governments, the level of government sometimes called “invisible.” We seek to shine a light on their role and how county government works. We also hope to educate members about how to be more engaged.

Using a common questionnaire, teams are researching each county website with an eye towards how visibly and accountably each of the 7 metro counties operate, how they engage the public and how they relate to other levels of government. How much of this information is available and easily found on the websites will speak volumes. After websites are plumbed, each team will set up interviews, as needed, with county managers, other staff, and county commissioners to finish the questionnaire.

In early January, we will send the final report to members in preparation for the **January 15 CMAL quarterly meeting** that we hope will be in person, with food. Members will determine if our 1975 county position is still relevant or if it needs revision and if we need a consensus for best practices recommendations to counties. If so, local Leagues will hold consensus meetings during February and March.
